Supervisor Weidmayer will attend the PDR meeting. SWWCOG has discussed the different recycling methods that each township has. BS&A website hits for the townships tax information were read. Property owners next to the Freedom Township cemetery on Waters road are discussing boundary lines. The DNR has signed an order to make feral swine and wild boar an invasive species in Michigan, if the legislature is not passed to regulate the facilities the order will go into effect and make it illegal to posse's wild boar in Michigan.
