Planning Commission report: Worked on zoning ordinance. A full copy of the PC minutes is available through the clerk's office.

Ordinance Enforcement Officer: DNR made a ruling that no wild boars are allowed in the State of Michigan, the wild boars are gone on Saline-waterworks. However the boars that got loose must be removed. Car at 11284 Hieber is still there, owner is having trouble finding someone to haul it away. Thirteen cars are still on the 10331 Ellsworth property, five have been removed.

C & T – There are issues that the township and attorneys are ironing out, should the letter of credit be extended again. The banks attorney is putting together a contractual agreement that would help with the costs of the violations. The other issue was the violations – how to solve, and how to get bids.
