2014-2015 Budget

WHEREAS, The Township Supervisor has prepared and submitted to the Township Board the proposed budgets for calendar year 2014-2015; and

WHEREAS, the Township Board has advertised the tentative millage rates in the Manchester Enterprise on Thursday, March 6, 2014 and held the public hearing on the budget and the tentative millage rates pursuant to Section 16 of the Uniform Budgeting and Accounting Act (Truth in Budgeting) on Tuesday, March 11, 2014; and

WHEREAS, the Township Board has reviewed the proposed tax rates and budgets.
